EAST INDIA ESTATE CONSERVATION AREA CONSULTATION The roads covered by H.O.M.E

form the major part of the East India Estate Conservation Area, which received its designation in 2008.

The aim of a Conservation Area designation is to preserve and enhance the special character and appearance of an area. So we need to think twice before we put up a satellite dish, add a dormer window or cut down a tree. Also, most developments in a Conservation Area need planning permission and some need Conservation Area consent. For more details see the Croydon council website, where you can also find out about the 'Croydon's Conservation Area General Guidance' document going for approval to Croydon Council on 22 April. PLANNING ISSUES 19 Ashburton Road - 6 different planning applications were submitted within a year. The last planning application - to create 11 bedsits - has gone to Appeal with the Planning Inspector in Bristol. We have had more than 70 objections. Let us hope the Appeal Inspector agrees with the residents and with Croydon Council and refuses it. The inspector has visited the site on 3rd April. The decision might take several weeks or months. We will let you know.

IMPORTANT - You will not get a letter about a planning application next door anymore. The Council has stopped sending letters to residents informing them of Planning Applications close to their homes. Instead they place notices on lampposts near the relevant property. This isn't particularly effective or reliable but the Council states that it saves them some money.

There is a direct link to the registration page via our own website under Planning Applications. You can also register on-line with Croydon Council and receive automatic notifications by email. Have a go and let us know how the on-line registration works for you!

MEMBERSHIP OF H.O.M.E.... HOME Residents' Association is 9 years old. It came into being as a result of the community getting outraged by a planning application to demolish one of the fine Victorian Villas. In 2006, there was another planning application to demolish 2 Victorian houses in Elgin Road - this was refused



and as a result we received our designation as a Conservation Area. In 2012 we have had a string of 6 planning applications in Ashburton Road - we are still battling with an application for an HMO – (house in multiple occupancy – see details above). The bonus - we now have Ashburton Road, Close and Gardens joining us in H.O.M.E. *The best outcome over the years that H.O.M.E has been in existence is that through working together to preserve and enhance the character of our area we have built a strong community.* If you are a resident of the H.O.M.E roads, membership of our Residents' Association is automatic. BUT if you *register* as a member of H.O.M.E each year this also gives you *membership of Neighbourhood Watch*and membership of Neighbourhood Watch can give you discount on your home insurance. A voluntary subscription, suggested as £5 per household, (or less or more if you wish) would be very welcome. OUR VIEWS ARE IMPORTANT!

As H.O.M.E represents 2/3 of the East India Conservation Area, Croydon Council has approached us for help in ascertaining residents' views on how the area should be managed and what we like about it.



The Council is in the process of preparing Conservation Area Appraisal and Management Plans for all of Croydon's 21 conservation areas to improve the effectiveness of heritage protection in these areas. This is being delivered during the course of the next two years in three tranches.

Tranche one underwent an eight-week public consultation from 1 August to 28 September 2012. Following this consultation, amended versions of the documents, including the Conservation Area General Guidance, were endorsed for adoption at Cabinet on 11 February 2013 and will be recommended for adoption as Supplementary Planning Documents (SPDs) at the Council meeting of 22 April 2013. They will become part of the legal framework when planning applications are considered.

Tranche two is currently being developed and this includes the East India Estate Conservation Area. The Council are keen to informally engage with the local Residents' Associations at this early stage, to hear our opinions on the East India Estate Conservation Area's special character, as well as what we feel are the key threats currently facing the area's short and long term protection. It is important to note that there will also be a formal public consultation on the draft of this document during the summer of 2013.

Your comments are invited on the points raised in the Questionnaire overleaf. Your answers will help to inform Croydon Council's Conservation Area Appraisal and Management Plan. Please return your responses to your local road coordinator (addresses below) by April 15th.
