## **HOME Traffic Report**

The Traffic sub-committee has adopted the following strategy over the past year:

- To raise awareness across the local and broader community of the unacceptable traffic escalation on HOME roads as a direct consequence of poorly planned traffic management in Addiscombe West.
- 2. To continue lobbying officers and politicians to do the right thing by residents in either a) extending the traffic mitigation scheme to include our roads or b) undo the changes made to date.

#### Point 1

#### Actions:

- Attempting to enhance our visibility online and using Twitter and Facebook more aggressively to expose the unacceptability of the situation.
- Conducting a leaflet drop to try to persuade more people onto our online platforms
- Continuing to raise profile of the deteriorating traffic situation via articles in the H.O.M.E newsletter (see the Christmas 2020 edition for the latest article)
- Writing directly to councillors and our MP as private residents to air serious concerns and personal impact of H.O.M.E traffic volume on individual lives and encouraging residents to do the same.

#### Successes:

- Ongoing exposure of the situation in our roads has led to unease amongst politicians and officers, some of whom have now acknowledged that the previous decisions in Addiscombe were a mistake
- We now have 145 followers on Twitter, up from single digits in 2020.

## Ongoing challenges:

• Despite our best efforts, it has proved challenging to motivate our local community to engage with our online platforms. This may be due to a lack of digital accessibility for some of our members.

## Point 2

#### Actions:

 Regular meetings with officers and politicians have been held all year, including with our MP and councillors.

#### Successes:

- Money has now been committed to reviewing the feasibility of an Addiscombe-wide traffic management review.
- Strong and positive relationships have been built with some politicians, particularly Muhammad Ali, Jessica Leigh and Sarah Jones MP.

## Ongoing challenges:

- The Council's current position of bankruptcy has left its leadership in disarray. Regular turnover of staff, a lack of funds and general malaise has meant that turning apparent goodwill into positive action has been extremely challenging to achieve.
- The extent to which residents are being 'managed' through goodwill and words of empathy, rather than helped to find assertive solutions, is difficult to establish.
- The politicisation of the matter (in a split ward) is fuelling a lack of transparency and consistency over motivation and intended action.

#### Main points for discussion and decision at the AGM:

- 1. Do we support, in principle, an Addiscombe-wide traffic management review and how do we best support politicians to turn intent into action?
- 2. How do we ensure our social media pressure is more consistent?
- 3. How do we better engage the broader community in our ward to get behind the drive for action?

## **Neighbourhood Watch Report**

The Safer Neighbourhood Team (SNT) are trying to get the East Addiscombe Ward Panel up and running again since Covid but haven't actually managed a meeting this year so far.

HOME organised a neighbourhood walk-around with some interested members and 2 officers from the SNT discussing a range of issues including anti-social behaviour and speeding traffic. This resulted in some graffiti being cleaned up and the SNT visiting a property known for playing loud music late at night. The process for addressing noise is now explained on the HOME website.

The Croydon Borough Neighbourhood Watch Association is having its AGM and Crime Prevention Day on Saturday, 6<sup>th</sup> November at the Royal Russell School. If you would like to attend, please let me know so I can arrange an invitation for you.

#### **Noise Pollution**

Croydon Council no longer has a 24 hour telephone hotline to report noise problems - their office hours are now standard (9am to 5 pm). Any sites where there are noise issues after those hours cannot be visited. You are encouraged to keep an audio recording of noise issues and keep a detailed log - when it started, when it finished, the impact it has had on you. One of our members is an audio expert and has offered to help if cases progress this far without resolution (call or email us for help). Ideally try to find out if there are other neighbours who have been affected by the noise.

They do seem to respond quickly via email <a href="mailto:POLLUTION@croydon.gov.uk">POLLUTION@croydon.gov.uk</a>

And, if the noise issue is remotely regular, they will open a case and send you a form to update with details. I think they need four specific events where the noise level was unacceptable to proceed with any action. If the noise comes from more than one household (in a block of flats/HMO etc.) you will need a separate reference number for each 'offending' neighbour. This makes complaining/getting a result more problematic.

## Planning Report (AGM Sept 2021)

Once again, the council has rejected most of the planning applications that we objected to in our conservation area in the last year. Notable ones were as follows:

In progress at the last AGM was the proposal to build a block of five flats on the garages site between Havelock, Outram and Mulberry, overlooking the backs of properties on all three roads and with difficult access. The proposal was rejected - thanks to all those who objected.

Adjacent to the previous one was a proposal to put a pair of semi-detached houses in the back gardens of 45-47 Outram, again overlooking and with poor access. Although rejected, this one has just been appealed but seems very unlikely to succeed.

At 19 Ashburton, Mr Datoo tried the appeal route after the council rejected his attempt to turn his back garden out-building monstrosity into a disabled flat. That appeal was recently rejected.

The developer of Appletree Cottage gave up and sold it after his reduced 4 flat scheme was rejected.

The large house at 86 Outram rumbles on. After initially proposing to turn it into six flats, a scheme for 3 flats seemed close to acceptance but was turned down on details. Instead of correcting the details, they are currently going down the appeal route.

Similarly, 37 Havelock finally accepted that three flats was the best they were going to get for the main house. However, they are appealing in an attempt to get their back garden dwelling approved (alias 'granny flat', alias 'office/storage').

The committee decided that it was not worth bothering all members of the residents association with many of the minor applications of which there have been a lot. In these cases Bob Porter has commented on behalf of the RA. One of these which we lost was a back extension at 50 Elgin.

In process are 10 Elgin, 54 Elgin, and a back extension at 56 Ashburton. It is now apparent that parts of the gardens at 50-56 Ashburton are being used to repair or deal in old cars and caravans.
